1. Opening Prayer and Welcome

2. Opening Prayer

Ms. Bernice Dubec led the Opening Prayer.

Ms. Nancy Bouchard, Chair, welcomed everyone and asked for introductions around the table.

3. Guest Presentation

3.1 Aboriginal Education Research Proposal

Ms. Alexa Scully presented the research proposal she has developed for her PhD project. This project proposes to study the place-based education as it relates to the cultural and territorial account of Aboriginal peoples in Canada and positive outcomes for Aboriginal learners.

This pedagogy seeks to transform the relations that non-Aboriginal Canadians have to the Aboriginal peoples and to the lands of Canada.

Place-based education is learning that is explicitly connected to the area. It includes teaching about the treaties and history and developing a cultural understanding.

Alexa asked O-AGC to support this research as a "community" to meet the Tri-Council requirements and the Research Ethics Board requirements. Alexa will report back to this group. O-AGC will discuss this at a later point in the meeting.

The definition of "community" and whether this support is necessary for this project was discussed. O-AGC is part of the governance structure and has as its membership members of the university community. It was also noted that the O-AGC itself could possibly be considered a "community" into itself. It was noted that this could be an important study related to emphasizing the importance of Aboriginal mandatory courses.

8.2 Smudging Protocol Policy

Ms. Yolanda Wanakamik and Ms. Ursula MacDonald introduced the Smudging Protocol Policy.

A copy of the new Smudging Protocol Policy was included with the package. Although this policy originated from a previously approved policy dated 2004, it has been extensively revised. O-AGC Advisors, Aboriginal faculty, Elders, and O-AGC all participated in developing this revised policy. Additionally, the number of days required for giving notice has been changed from 4 to 5 days since the policy was distributed to the Advisors to accommodate the requirement that notice be given in a Communications Bulletin.

MOVED (Y. Wanakamik/S. Wolf) that the O-AGC endorses the approval of the Smudging Protocol Policy by the Office of Human Resources. CARRIED

Both O-AGC and the Indian Friendship Centre could appropriately be considered "community". Instructors and Aboriginal and non-Aboriginal faculty members would be the study group questioned. This study may provide answers that would assist faculty in developing the required Aboriginal content courses.

O-AGC would require reporting twice per year. O-AGC should request focussed reporting on assisting with the Lakehead University roll-out of mandatory Aboriginal courses.

It was noted that Alexa Scully has supervisors and an advisory committee. Also, with regards to restrictions, she is entitled to academic freedom. O-AGC cannot set additional conditions on the project.

MOVED (B. Stevenson/S/ Wolf) that an ad-hoc committee be struck to investigate the Research Ethics Board issue and that Dr. Raymond Neckoway, Dr. Peggy Smith, and Ms. Bernice Dubec participate on that committee.

O-AGC may support this project but there is no obligation to support other research projects.

Mr. Paul Capon reported that federal legislation on Aboriginal education is being developed. This will be an on-going project over the next year. There will be implications on post-secondary educational institutions. A suggestion was made that someone look into what other universities are doing related to this.

Mr. Paul Capon summarized the presentation held on April 12, 2013. He noted that the purpose of the Centre was to ensure dialogue among the players. He noted that Ontario is quite behind other provinces in the Aboriginal consultation process.

Ms. Sandra Cornell noted that twelve students are graduating that started with the NNEP. That will bring the total number of students to 63 who began with NNEP and have graduated (most returned to their communities).

Dr. Herman van den Berg noted that the interview process for the Aboriginal Liaison Advisor in Orillia will begin tomorrow.

10.8 Senate

Dr. Sandra Wolf provided a summary of the issues that Senate has been dealing with – the Law School issue, changing the day/time of Senate meetings to Mondays, and the math requirements testing for Education.

10.9 President's Report

Dr. Brian Stevenson and Ms. Kathy Pozihun are working with the Ministries to ensure that the Kendaasiwin Centre is shovel ready. At this time there is no funding but the Ministers are being updated and consulted on this project.

O-AGC will be asked to obtain letters from the region to support the project. Fund-raising campaign will begin shortly with Ms. Deb Comuzzi leading. The architect's plan will be ready shortly.

Final branding of the Achievement Fund will be unveiled shortly. For every \$2,500 donated today, a child of about 10 years old will be funded for their first year's tuition at Lakehead University.

Daycare Centre will completed by September 2014. It will be located over by the Hanger.

The telepresence proposal is being finalized.

The Law School required first year courses have been referred to Senate committees.
