4. Business Arising from the Minutes

a) Recruitment and Retention of Aboriginal faculty questionnaire

Dr. J. Hodson had presented his research on the Recruitment and Retention of Aboriginal faculty questionnaire which included recommendations. The committee began a discussion of the recommendations and decided that they will read the draft research report. A. Dokuchie will circulate a copy of the draft research report to committee members by interoffice mail. (ACTION)

The recommendations from his presentation will be reviewed again in further detail at the O-AGC Advisors Committee meeting on November 6, 2012. (ACTION)

b) Bi-Annual Self-Assessment Report to O-AGC

Ms. A. Schroeter advised that Dr. P. Smith, Former Chair of the O-AGC Advisors Committee had presented the Bi-Annual Self-Assessment Report to O-AGC at the meeting held on September 24, 2012.

As follow up from this report, a presentation to Deans' Council explaining the workings of the Advisors Committee still needs to be organized with the Office of the Provost and Vice-

President (Academic). Ms. A. Schroeter will follow up to ensure a presentation is made to the Deans' and an update will be provided at the next meeting. (ACTION)

c) Lakehead University Website Update

Ms. Y. Wanakamik advised that legal agreements need to be finalized before images of the George Ward Art Collection can be featured on the Lakehead University website. Artists or those individuals managing their estates will have to be contacted and permission granted. Ms. Jennifer Childs, Office of University Advancement will be developing a plan for this moving forward.

Ms. A. Schroeter advised that Ms. Tove Tronslien, Manager of Web Development Services will be giving a presentation on the changes to website at the O-AGC meeting on October 29, 2012. This is an opportunity for O-AGC members to provide feedback to Ms. Tronslien on how the website can be improved before it is launched to the public.

b) Ne-tum-ochee-ebek (First Roots) Update

Ms. Y. She has begun this process and has developed a draft framework for forming these priorities.

Ms. K. Roche, Secretary of O-AGC advised that it would be ideal to have a final O-AGC Strategic Plan completed by February 2013. She also suggested that this sub-committee focus on its top twenty priorities for O-AGC's consideration.

Mr. B. Beardy will look into the translation of "First Roots" and will provide an update at the next meeting. (ACTION)
