1. Guest Presentation

Mr. Colin Bruce, Chair of the Board of Governors at Lakehead University spoke to the O-AGC about the background and process related to the work undertaken by the Board related to its restructuring. The changes will be effective following the Board's Annual Meeting in September 2012.

These changes will result in a smaller and more effective Board. Over the next two years, the Board size will be reduced to approximately 18 members and 6 standing committees.

O-AGC will continue to have a representative on the Board of Governors.

7. Other Business

7.1 Ayaminaaniwan – Having a Voice Roundtable

Ms. Judi Nelson-Childs summarized the discussions that took place at the Roundtable event. Ms. Nelson-Childs explained that the study was conducted between the ONWA and the City of Thunder Bay involving Aboriginal participation in municipal government. Based on the population in the City, it is notable that Aboriginals are under-represented on City Council.

The follow up to the study was a Roundtable discussion to find solutions to increase Aboriginal participation in elections and the political process.

A summary of the results was distributed.

The City of Thunder Bay and ONWA are continuing to work on this. Ms. Anna Gibbons has contacted Beverly Sabourin to develop a partnership with Lakehead University in pursuing strategies to follow up.

7.2 Priorities and Issues - Updates from external organizations

Senator Ruth Wagner thanked Ms. Beverly Sabourin for all of the work she has done at Lakehead University to move forward with Aboriginal agenda and to April Jones who is organizing the Elders Program in Orillia.

Ms. Nancy Bouchard noted that the Anishinabek Employment and

Training Services has been working with the Pic River First Nation on an entrepreneur training program. AETS has also been working with Confederation College on "How to Run a Guiding Business". Sawmill training is on-going with Fort William First Nation. A mining training program is underway in Marathon. Participants should have jobs in gold mining upon completion of the program. A water-treatment training program is underway in Greenstone.

The Anishinabek Employment and Training Services is working with Lakehead University as a referral agency for the Humanities 101 program offered by Lakehead University to provide individuals with an introduction to what the university is and the opportunities education can offer.

7.3 O-AGC Advisors Report and Recommendations

Dr. Peggy Smith noted that the O-AGC Advisors met in May. Dr. John Hodson gave a preliminary report on the results of the study on Aboriginal Faculty Retention and Recruitment. This will be discussed further at the O-AGC Retreat on June 25th and a full printed report will be available prior to that meeting.

7.3.1 Bi-Annual Self-Assessment Report to O-AGC will come forward to O-AGC on June 25th.

7.4 Condolences

Dr. Sandra Wolf distributed a handout explaining an issue that arose when the Band Chief in Moose Factory passed away recently. When the Education Department requested that a condolence notice be posted in an Lakehead University Communication Bulletin, the request was declined because the policy of that office did not define Chief Kapashesit as having a specific connection to Lakehead University.

Dr. Wolf asked that O-AGC consider how the University determines who the individuals are that the University has relationships with. Are they Band Chiefs, Band leaders, etc.? She asked that O-AGC consider looking into this.

O-AGC could give consideration to defining important Aboriginal and Metis relationships and begin to create a list of those names. It should be determined whether there is a policy and what considerations would/should be included in the Communications policy. The Secretary will speak with the Office of Communications to determine if there is a policy that addresses notices.

8. Update on Gichi Kendaasiwin Project

A folder of printed materials related to the Kendaasiwin Project was sent to all voting members in April 2012.

Dr. Brian Stevenson updated the O-AGC on the Gichi Kendaasiwin Project and the recent MOUs with local schools interested in participating in the Achievement Fund scholarship project.

Dr. Stevenson thanked those who assisted and participated in the Royal LePage Walk-a-thon to raise funds for the Achievement Fund.
