1. Opening Prayer and Welcome

Mr. Bruce Beardy led the opening prayer.

Ms. Nancy Bouchard, Chair welcomed everyone and introductions were made around the table and via teleconference.

2. Guest Presentations

2.1 Lakehead University Website

Ms. Tove Tronslien, Manager, Web Development Services reviewed the process used to develop the new website. A consultant was hired to conduct stakeholder interviews with users and administration to determine the goals for the site and how to organize the site. The new website will require each unit to be responsible for its own content such as images, video and text.

The University is working toward a new "branding" and if changes are necessary, the website will be updated to reflect the current branding exercise results.

Roll-out will likely be before the end of February. Ms. Tove Tronslien noted that feedback is welcome.

Syllabics run left to right not up and down. There is a character missing. Mr. Bruce Beardy noted that the colours are too light and fade in the background.

2.2 "What are the Strategies for Supporting Aboriginal Research at Lakehead University Going Forward?"

Dr. Rui Wang, Vice-President, (Research, Economic Development and Innovation) noted that the objective of research going forward will be – "continuing what we are doing and doing it better". Research uses the following strategy: formulate a strategy; build up capacity; provide resources; and measure success.

What metrics are used to measure Aboriginal research? As a whole, Lakehead University should be very proud of its work in Aboriginal research. There have been 73 Aboriginal research projects in the last year. Publication intensity is another measure. Lakehead University is on top of the nation in publishing. Ranking – Lakehead University is number one in the area of Aboriginal research and publications.

Aboriginal research is not isolated. It is supported by all Faculties and by students. The Research Office and the Aboriginal Initiatives work together on very successful initiatives.

The Research Plan, the Academic Plan, and the Strategic Plan all list Aboriginal research as the highest importance.

How will Aboriginal research be supported over the coming years? Every academic unit is preparing its workplan. There will be a new Mining Centre of Excellence – the Centre will be focussed on partnerships with Aboriginal communities.

3. Approval of Agenda

5. Approval of Minutes

MOVED (J. Flett/Y. Wanakamik) that the Minutes of the O-AGC meeting of November 19, 2012 be approved. CARRIED

6. **Business Arising from the Minutes** (not on the Agenda elsewhere)

6.1 Recommendation request for "One full time faculty member whose research involves Aboriginal people" to serve on the Research Ethics Board (REB).

Dr. Maundrell reminded the O-AGC that he was here to discuss the memo that O-AGC sent to the REB asking that the REB set up a subcommittee to review proposals for Aboriginal research. Dr. Maundrell had discussed this concept with the REB since the last O-AGC meeting. The REB was not in favour of creating a sub-committee to review Aboriginal research proposals. Dr. Maundrell noted that the REB's Terms of Reference do provide for an individual with legal expertise and an individual with experience in aboriginal research. Dr. Maundrell noted that the TCPS 2 requires all REBs to perform a careful review on Aboriginal research proposals with respect for cultural differences.

He noted that Ms. Karen Drake will be returning to the REB. Two community members are on REB. When one of them retires, the vacancy may be filled with an individual from an Aboriginal community. If there is ever a question about expertise around the table additional ad hoc committee members can be appointed to assist as stated in the Terms of Reference.

The REB asked the O-AGC to recommend someone to fill that position using the structure as it is now. A faculty member noted that Aboriginal faculty members are so few at LU that the proposal was intended to create a way to share the communal work. Many committees have the mandate to include an Aboriginal faculty member and therefore the Aboriginal faculty members have increased demands on their time.

There was no recommendation for an individual to fill the position on the REB.

MOVED (S. Wolf/J. Flett) that the REB or representatives of REB be invited to have a discussion with O-AGC about reconsidering their decision pertaining to the establishment of a sub-committee to review Aboriginal Research projects.

CARRIED

6.2 Update on Draft Terms of Reference for the O-AGC Committee to Liaise with the Mineral Exploration and Sustainable Mining Development

Dr. Peggy Smith reported on the draft Terms of Reference that were developed and distributed by email.

MOVED (S. Wolf/R. Hanley) to accept the Terms of Reference for the O-AGC Committee to Liaise with the Mineral Exploration and Sustainable Mining Development.

7.1 Appointment of Representative from the Thunder Bay Indian Friendship Centre

Notice of Motion and a copy of the correspondence from the Thunder Bay Indian Friendship Centre were distributed by email on December 7, 2012.

MOVED (T. Pile/K. Beardy) that Ms. Tamara Spence be appointed to the O-AGC as the representative from the Thunder Bay Indian Friendship Centre and that Mr. Wilfred King be appointed as her alternate. CARRIED

O-AGC will send a letter asking if Mr. Wilfred King will be continuing on the Lakehead University O-AGC.

7.2 Revisions to the O-AGC Bylaws

Dr. Peggy Smith noted that a Notice of Motion was given at the November 19, 2012 meeting. Revisions were distributed to O-AGC voting members by email on January 15, 2013.

MOVED (S. Wolf/Y. Wanakamik) that the revisions to the Ogimaawin-Aboriginal Governance Council Bylaws be approved. CARRIED

It was noted that the Bylaws now allow for the appointment of an Aboriginal faculty member to the O-AGC.

MOVED (S. Wolf/Y. Wanakamik) that Dr. Raymond Neckoway be appointed as the Aboriginal faculty member. CARRIED

7.3 Joint SAC/O-AGC Update

Dr. John Hodson updated the O-AGC on the work being undertaken by the Joint SAC-O-AGC.

7.4 Proposed O-AGC Meeting Schedule 2013-2014

Ms. Nancy Bouchard requested that O-AGC give consideration to 1:30 pm. start time for O-AGC meetings.

By consensus it was agreed that meetings will begin at 1:30 pm. Every effort will be made to end the meetings by 3:30 pm.

Dr. Sandra Wolf summarized the Advisors Report. Dr. Wolf will be on sabbatical next year therefore her position on the Advisors and on Senate

will need to be filled.

8.3 Update on the Vice-Provost, Aboriginal Initiatives Search

Dr. Rodney Hanley reported that the Search Committee has been struck and has met twice. The position has been advertised nationally. Thirty applications were received and interviews are expected to begin within the next few weeks.
