## 1. Opening Prayer and Welcome

#### 2. Guest Presentation

Aboriginal Self-Declaration Statistics and Project Update

Ms. Sarah Browne provided members with the results of the 2015-2016 Aboriginal Self-Declaration Survey that was conducted by Lakehead. Highlights included:

- Breakdown of the statistics
- Estimated number of Aboriginal students at Lakehead (2010-2016)
- Aboriginal self-declaration 2015-2016 by campus
- Aboriginal self-declaration by faculty
- Aboriginal self-declaration by academic level
- 2015 self-declared Aboriginal graduates

In addition to the statistics presentation Ms. Browne reported that updates are being made to the current Aboriginal self-identification process to reflect the best practices of the Council of Ontario Universities (COU). It was estimated that the updated Aboriginal self-identification section of the Lakehead website will be ready to launch in the spring 2017. The next step will be to update the Aboriginal self-identification survey.
