(September 19th, 2016 through January 30th, 2017)

Chair on Truth and Reconciliation (Administration)

The CTR was appointed to the position of Chair on September 16, 2016 at the Bora Laskin Law School. There were several dignitaries in attendance, including Indigenous leadership, and federal and provincial ministers.

The purpose behind the appointment was to strengthen the ability of Lakehead to perform consistent and far reaching engagement with Indigenous leadership and communities local to Lakehead in NW Ontario, but also regionally and nationally to enhance Lakehead's position as a destination for Indigenous education in Ontario and Canada.

In addition, the Chair is tasked with updating and informing the President of Lakehead University about educational and political developments within the Indigenous community across Canada, and ensuring Lakehead is observed as a primary institute in the implementation of the Truth and Reconciliation Commissions "94 Calls to Action" and the "13 Principles" tabled by the University Presidents on Indigenizing the Academy.

The Chair filed two proposals before the end of September 2016, one to the Provincial government and one Federal to bring people together across the NW and deal with Policing and Justice issues. On December 12th both proposals were returned for revision and redirection. The CTR had them both out the door before January 30th 2017.
