**Program Requirements:**

**Six Year Non-Direct Entry Program**

Students enrolled in the HBAsc/BEd [Interdisciplinary Studies Major] P/J may only switch into this program if academically ineligible to continue in or complete the Honours program, and with the permission of the Chair of the Department of Interdisciplinary Studies.

In the BAsc/BEd [Interdisciplinary Studies Major] P/J 4 Year program, an overall Interdisciplinary Studies Major average of 60% is required. The Interdisciplinary Studies Major consists of 12 FCEs: two (2) FCEs of Interdisciplinary Studies courses, five (5) FCEs in the first discipline, and five (5) FCEs in the second discipline.

In Concurrent Education programs at the Primary/Junior level, students must meet and complete requirements of the partnering degree program including all Pre-Professional Program Education requirements (see Concurrent Degree Programs Information for Education requirements). A student registered in a Concurrent Education program must maintain a minimum cumulative average of 65%.

**Note 1:**

All students will satisfactorily complete three Interdisciplinary Studies courses: one-half (0.5) FCE at first-year level, one-half (0.5) FCE at third-year level, and one (1) FCE at fourth-year level.

**Note 2:**

Students must complete five (5) FCEs in one discipline and five (5) FCEs in a second discipline: one (1) FCE each at the first-year level, two (2) FCEs each at the second-year level, and two (2) FCEs each at the third or fourth year level. Eligible disciplines are Anthropology, Biology, Criminology, English, General Science (as defined as a "Teachable" by the Faculty of Education), Geography, History, Media Studies, Political Science, Psychology, and Sociology. A course may only count toward one discipline.

By the end of four years (20 FCEs), at least three (3) FCEs must be Type A (Humanities) or Type B (Social Sciences) courses; at least three (3) FCEs must be Type C (Engineering, Mathematical and Natural Sciences) or Type D (Health and Behavioural Sciences) courses; and at least one-half (0.5) FCE

| Pedagogical rationale for<br>this proposal. Why are you<br>submitting this request?: | Beginning in the 2015/16 academic year, the Department of Interdisciplinary Studies introduced substantive changes to its HBASc (IS Major)/BEd Primary/Junior degree by offering students the opportunity to add a thematic concentration to their program of study. Three new HBASc/BEd degrees with concentrations in Human Nature, International Conflict & Human Rights, and Social Justice were approved by Senate and are now Calendared, and a fourth concentration in Environment in Politics and Culture has been submitted to the Senate approval process in 2016/17. The IS Department now proposes to add four-year BASc/BEd degrees to correspond to the original HBASc/BEd IS Major degree and to the HBASc/BEd IS Major degrees with these concentrations. The four-year BASc option was added to the stand-alone HBASc IS Major in 2015/16, and other departments in faculties across the University have moved to add a four-year degree from their Bachelor's degree to their |

add a non-direct entry four-year bachelors option to their degree structures, including Honours programs offering concurrent Education degrees with the Faculty of Education. Establishing a four-year BAsC option within the IS Major/BEd program and the IS Major/BEd program with concentrations provides benefits to students who are unable to meet the 70% HBAsC average requirement and to the University by improving student retention and allowing students to graduate from a four-year program with the concentration before entering the Professional Years in Education. Students who would currently be completing the third year of the HBAsC/BEd IS Major or the HBAsC/BEd IS Major with a concentration but who do not appear likely to meet the Honours average requirement might choose to immediately move to a three-year BAsC/BEd option instead of entering the fourth year of their studies in either the HBAsC/BEd or the four-year BAsC/BEd programs. Furthermore, students completing the fourth year of their HBAsC/BEd studies who have satisfied all of the program requirements of the IS Major or the IS Major with a concentration but who have not met the 70% Honours average are required to retake courses in an effort to raise their average, which has a negative financial impact on students and is frequently not successful. The proposed four-year BAsC/BEd IS Major and BAsC/BEd IS Major with a concentration degrees have the identical program requirements as the respective HBAsC/BEd IS Major and HBAsC/BEd IS Major with a concentration degrees they mirror, with the exception that the minimum average requirements in the Major and concentration will be 60% instead of 70%.

The Interdisciplinary Studies Major consists of 12 FCEs: two (2) FCEs of Interdisciplinary Studies courses, five (5) FCEs in the first discipline, and five (5) FCEs in the second discipline.

In Concurrent Education programs at the Primary/Junior level, students must meet and complete requirements of the partnering Honours degree program including all Pre-Professional Program Education requirements (see Concurrent Degree Programs information for Education requirements). A student registered in a Concurrent Education program must maintain a minimum cumulative average of 65%.
