Pedagogical rationale for Pedagogical rationale for this proposal: In 2012 the MES NBRT this proposal. Why are you program underwent a cyclical review. The reviewers identified a submitting this request?: number of areas where the program could be altered to address student and faculty concerns, enrolment issues, and the sustainability of the program. Our faculty complement had declined from 11 full time faculty members at the program's conception to 8 at the time of the review (we currently have 6 full time faculty). In addition, student enrolment in the MES-NBRT had declined to an average of 3 entering students. These two factors made it apparent that it was not sustainable to continue to offer the program in its original structure (2.5 FCEs of required courses) as this took resources away from our undergraduate program and/or required faculty to be teaching on unpaid overload. As such, we put the program into abeyance over the academic terms from 2013-15 to determine how best to sustainably move forward. Three of our faculty members are cognate members of the MES-NECU program, and we have shared teaching of a 1.0 FCE methods course over the past three years. It was therefore logical to begin discussions regarding the potential to jointly offer our two programs as a way to sustain both degrees over the long term. The MES-NECU has had a more robust enrolment over its history, but there is potential for that to change as the Anthropology Department works to develop an MSc (ANTH). Through several meetings our two programs have developed a joint MES that would allow us to share teaching of required courses, create a robust graduate culture among three departments (Anthropology, Geography and ORPT), create a truly interdiscipplinary MES that crosses two faculties (SSH and SES) and which allows the sustainable continuance of the two degrees while not compromising the integrity of the undergraduate programs in these departments. In the proposed program, MES NBRT and NECU students would take the following required courses: 1.0 FCE of methods courses 0.5 FCE content course 0.5 FCE elective Remaining FCEs comprised of thesis work We would have one Graduate coordinator for this merged graduate program, who would be responsible for the organization of the content course and who would receive 0.5 FCE teaching release. The content course would be team taught. We would continue to teach 0.5 FCE of the methods course, and electives would either be cross-listed courses with our undergraduate program or directed studies. As such, our faculty teaching requirements would be significantly reduced and thus not negatively impact our undergraduate degree. Interest in our MES NBRT program has continued as evidenced through enquiries received from international, domestic and within our program, students. We are also nurturing a research culture within our undergraduate students through the development of Honours Thesis seminars, presentations and publications which will contribute to growing our MES from within. The nomenclature of the degree (Master of Environmental Studies in Nature Based Recreation and Tourism) remains appropriate as it has resonated with students since its inception and builds from our HBOR degree.

The MES in Nature-Based Recreation and Tourism consists of five full course equivalents of which the thesis, Outdoor Recreation 5901 (9901), is equivalent to two FCEs. The student will take two and one-half FCE required courses: Outdoor Recreation 5010, 5030, 5050, 5131 and 5133. The remaining half-course equivalent elective may be taken from graduate courses in Outdoor Recreation. Subject to the approval of the academic units, students may choose their half-course elective from graduate courses offered outside the School.
