Program Requirements:	<p>Two Year program (includes spring/summer term)</p> <p>An overall B 70% average in the Media Studies Major (courses designated with an asterisk*) through each year is required.</p> <p>Graduates from any six semester (3-year) Graphic Design program in Ontario, or any four semester (2-year) Photography program in Ontario, with a 70% cumulative average or higher, may be admitted to the Honours Bachelor of Arts and Science (HBAsc) Media Studies College Pathways program. College transfer students will be credited with 8.5 FCEs towards the HBAsc (Media Studies Major), reducing the remaining requirements to 11.5 FCEs (with an overall average of 70% in Media Studies) as outlined below. Students lacking at least two (2) half-courses (equals 1 FCE) of Type C or D courses in their college program will be required to take them at Lakehead in addition to the courses listed below. Meeting the minimum requirement does not guarantee admission to either the University or a specific program. An overall average of 70% in Media Studies is required for graduation from this program.</p> <p>Note: In fulfillment of the requirements of the HBAsc, college transfer students must take at least two (2) FCEs of Type A or Type B courses; at least two (2) FCEs of Type C or Type D courses; and at least one-half (0.5) FCE of Type E courses. The Indigenous Content Requirement is being met by the inclusion of one-half (0.5) FCE chosen from the list of Type E courses taken as an elective in any year of the program (MDST 2310 or MDST 4550 recommended). Pedagogical rationale for this proposal. Why are you submitting this request?:	<p>There are a few minor changes to the program. First of all, the type A, B, C, and D courses breadth requirements are being identified more specifically and notes are added to the elective lines to remind students of the requirements. Secondly the Indigenous Content requirement is being met via Type E courses, as indicated in the note. Thirdly, in keeping with the new concentrations introduced this year, we are enabling students to fulfill the third year inquiry requirement via any of the third Interdisciplinary Studies courses (INTD 3010, 30aa, 30xx, 30yy, or 30zz, see 2015-sec-5324).</p> <p>This proposal adds Photography to Graphic Design as another source program for the existing pathway. It adds a restriction line to prevent redundancy with college photography programs. And it also reflects the change in program title and the streamlining of program course requirements, as per Calendar change request 2018-SOC-6711.</p>
