Course Description: In this course you will study horror films as cultural narratives that support and/or challenge hierarchies of gender as it intersects with race, class, sexuality, age, and other identity positions. You will learn and use feminist film theories such as cultural, psychoanalytic, audience response, and queer feminist film studies to analyze the films. By the end of the course, you will be able to read, interpret, and analyze the role that horror, as a genre, plays in the cultural reproduction of gender-linked hierarchies, and how feministlinked horror films challenge traditional cultural tropes that define women, mothers, and the feminized as uncanny, unnatural, or just plain evil.
