Studies, and this request pertains to the cross-listing of one of those English courses under a Media Studies code. This course includes the study of contemporary storytelling genres which include film, TV, music and digital media, as per the course description, therefore it is directly applicable to Media, Film, and Communications students. Moreover, it will provide another option for MDST students to fulfill their 0.5 FCE Type E course requirement. Currently the MDST program offers Type E courses with Indigenous content in second year and fourth year, but not in third year, so the new cross-list offers students greater flexibility.
