Period of Study

The MA program in History is both flexible and responsive to the needs of students. The program accommodates a wide range of interests and allows students to pursue their studies via a Thesis, Major Research Paper or Course streams. In addition to providing three different streams of study, the department also offers a choice of full-time or flex-time studies. Full-time is the standard route for most students. Flex-time is intended for working professionals and others who are unable to commit to full-time study to obtain their MA.

Full-Time vs Flex-Time

Standard Full-Time Period of Study

Students in a Master's program are expected to complete degree requirements within six terms (2 years) of continuous full-time registration.

Flex-Time Period of Study

The Flex-time option is available to all students (subject to the approval of the Department) and it allows students to complete degree requirements within 12 consecutive terms (4 years) as follows:

- Six (6) terms (2 years) of continuous full-time registration;
- Up to six (6) additional terms of continuous registration, during which no fees are required.

As the flex time option is intended for working professionals, students will not normally be considered for financial support from the University.

· Rationale: Why are you To provide an opportunity for working professionals such as submitting this request?: school teachers to enrol in our MA program while continuing to work. In the past, many of our students were education students who returned after their BABEd for an MA. With the changes in curriculum requiring an extra year to complete the BABEd, students are opting to work rather than study. This is a compromise that recognizes their desire for an MA by permitting them to enrol as "flex time" students. Similarly, allowing both a September and a January start in the MA program will provide an option that students have inquired about. These two changes will help attract students who otherwise would not consider an MA in our department.
