Four Year program

An overall 70% average through each year is required in the Media, Film, and Communications Major (courses designated with an asterisk*) through each year is required and any additional elective Media, Film, and Communications courses taken.

Note:

By the end of four years (20 FCEs), at least three (3) FCEs must be Type A (Humanities) or Type B (Social Sciences) courses; at least three (3) FCEs must be Type C (Engineering, Mathematical and Natural Sciences) or Type D (Health and Behavioural Sciences) courses; and at least one-half (0.5) FCE must be Type E courses. The Indigenous Content Requirement is being met by the inclusion of one-half (0.5) FCE chosen from the list of Type E courses taken in any year of the program (Media Studies 2310 or Media Studies 4550 recommended).

Pedagogical rationale for A title change for the program is being requested to integrate this proposal. Why are you the existing and proposed film production courses into the submitting this request?: program. The title change reflects a gradual increase in program content regarding digital media, also evident in contemporary media and communication studies. Making these existing elements of our program transparent will make it more appealing to prospective students. The fundamental critical and theoretical emphasis of the program remains unchanged. In terms of courses, one required production course is being introduced at the first year level, and one required theory course is being removed at the second year level. The budget impact, therefore, is neutral. The description of the major average calculation has been altered to accurately reflect the current Enrolment Services method of calculating this average, and VISU 1015 has been added to the list of eligible courses under line (c) of the First Year requirements.

Graduates from any six semester (3-year) Graphic Design program in Ontario with a 70% cumulative average or higher, may be admitted to the Honours Bachelor of Arts and Science (HBASc) Media, Film, & Communications College Pathways program. College transfer students will be credited with 8.5 FCEs towards the HBASc (Media, Film, & Communications Major), reducing the remaining requirements to 11.5 FCEs (with an overall average of 70% in Media, Film, & Communications Major) as outlined below. The minimum requirement for Type C or D courses (see Note 1) may be increased by up to 1 FCE depending upon the student's college diploma. Meeting the minimum requirement does not guarantee admission to either the University or a specific program. An overall average of 70% in Media, Film, & Communications is required for graduation from this program.

Notes:

- In fulfillment of the requirements of the HBASc, college transfer students must take at least 2 FCEs of Type A or Type B courses; at least 2 FCEs of Type C or Type D courses.
