Why are you Education program was being revised from a one-year to a twoyear program, discussion was given to accelerating Honours Concurrent programs from the proposed six years to five years. Based on evidence from other jurisdictions that had extended teacher education programs to six years, concerns at the time centered on the perception that a six-year program would be unattractive to many students. Since the introduction of the current Education Programs in 2015, discussions have continued in an effort to accelerate the programs, leading to the current proposal. Given that the accreditation of Education Programs requires those programs being four semesters in duration, the acceleration of Concurrent Education programs can only occur in the undergraduate partner degree. Thus, the only changes that are proposed in the Accelerated Programs are for both Pre-Professional Education and partner degree courses to be offered in the Spring/Summer semesters that will allow students to complete their undergraduate programs in three years. Students will not be permitted to accelerate any part of their program in the First Year Fall and Winter semesters, as all the Chairs believe such a move could be counterproductive to student success. The Chairs of the Departments involved in this proposal will be responsible for the selection of those courses, and will inform their Deans of their requirements. The Deans of Social Science and Humanities, Science and Environmental Studies, and Education have all agreed to this funding model, as outlined in the attached memo. As the program requirements are remaining the same, there is no need for new

to student files to track students who are accelerating. This is important as the Faculty of Education needs to ensure that all program requirements are met before a student enters the Professional Program, and that students receive important information regarding preparing for placements that start in October. The Education Professional Program is unchanged by this proposal. Depending on the uptake of these Accelerated Programs, it is envisaged other Concurrent Programs may be accelerated in the future These are housekeeping changes and updates to the HBASc/BEd IS Major and BASc/BEd IS Majors in Concurrent Education. First, the list of eligible courses to satisfy the second year methodology course requirement has been updated to include Chemistry 2111, Chemistry 2211, Business 2312, and French 2101. Students now have the opportunity to take 5 FCEs in Chemistry in Orillia to satisfy the requirements of the IS major, and this degree also offers a fall-back option for Applied Life Sciences students who do not continue in the Lakehead/Georgian program. Orillia students have expressed a longstanding interest in a business disciplinary area within the IS major. Working with the Business program in Orillia, the Entrepreneurship disciplinary area has been developed that can be applied to satisfy the IS major requirements—these business courses are already offered in Orillia and do not require additional resources. French is a subject in high demand in Orillia. Political Science 2555 is being removed from the list of eligible methodology courses.3) Women's Studies has been added as a disciplinary area. to include Chemistry 2111, Chemistry 2211, Business 2312, and French 2101. Second, Chemistry, Entrepreneurship, and French have been added as disciplinary areas. These three disciplinary areas will add welcome diversity to the range of disciplinary areas currently offered in the IS major programs. Chemistry programming has been significantly expanded on the Orillia campus because of the Lakehead/Georgian Applied Life Sciences program. Students now have the opportunity to take 5 FCEs in Chemistry in Orillia to satisfy the requirements of the IS major, and this degree also offers a fall-back option for Applied Life Sciences students who do not continue in the Lakehead/Georgian program. Orillia students have expressed a longstanding interest in a business disciplinary area within the IS major. Working with the Business program in Orillia, the Entrepreneurship disciplinary area has been developed that can be applied to satisfy the IS major requirements-these business courses are already offered in Orillia and do not require additional resources. French is a subject in high demand in Orillia. Interdisciplinary Studies has traditionally paid for core French courses as part of the Concurrent Education program, and the Department of Languages has committed to expanding French offerings available to Orillia students to allow enough courses to be offered for the French disciplinary area. Third, language is being added to

specify that students in nowoc and page degrees cannot count INTD courses to breadth requirements unless they are being taken as electives.
