The Interdisciplinary Studies Major has four concentration options in the thematic fields of Environment in Politics and Culture, Human Nature, International Conflict & Human Rights, and Social Justice. The other two majors within the department are in Criminology and Media, Film and Communications, both of which attract students with an interest in social justice and would prepare them for an MA in Social Justice Studies. The Orillia undergraduate offerings are actually a more direct preparation for an MA in Social Justice Studies than most of the Thunder Bay undergraduate offerings, so establishing the program in Orillia will provide a clearer path to graduate studies for Orillia undergraduates in Interdisciplinary Studies. The course option will be manageable for Orillia-based students. Students will have Orillia-based courses (including different electives each year), online (Zoom or asynchronous), and Thunder Bay courses delivered via Telepresence or Zoom to choose from.

The rationale for offering the MA in Social Justice Studies will be an innovative, interdisciplinary program drawing upon the expertise of multiple faculty members both within Social Sciences and Humanities, and in Science and Environmental Studies and Health Studies to maximize the use of existing resources, to provide opportunities for graduate student supervision for faculty in departments without graduate programs. The new MA will be housed in Social Sciences and Humanities and attract students from across the country and potentially international students, and will provide a unique opportunity for graduate growth and student retention at Lakehead University. This MA will provide a concrete manifestation of the commitment of the university, as stated in the strategic plan, to produce socially aware and justice-oriented students. Eight students graduating from the Orillia campus or living near Orillia have been accepted for 2021-22 and one Thunder Bay undergraduate has expressed interest in moving to the Orillia campus. The program expects to enroll 10+ students from Simcoe County and surrounding areas once the program is offered as a bi-campus program, equally accessible to students from Orillia or Thunder Bay. International students would be able to choose the Orillia campus, something incoming graduate students have already asked about. The Interdisciplinary Studies Department on the Orillia campus offers several HBASc majors that can prepare students for the Social Justice Studies MA Program. The Interdisciplinary Studies Major has four concentration options in the thematic fields of Environment in Politics and Culture, Human Nature, International Conflict & Human Rights, and Social Justice. The other two majors within the department are in Criminology and Media, Film and Communications, both of which attract students with an interest in social justice and would prepare them for an MA in Social Justice Studies. The Orillia undergraduate offerings are actually a more direct preparation for an MA in Social Justice Studies than most of the Thunder Bay undergraduate offerings, so establishing the program in Orillia will provide a clearer path to graduate studies for Orillia undergraduates in Interdisciplinary Studies. This is a change in name only. All learning outcomes and resource allocations remain the same. The name change reflects what we are already doing in the program. The research project option will be available to students in Orillia whose interests align with Orillia faculty. But Orillia students may also work at a distance with Thunder Bay faculty if both students and faculty are willing to work remotely. These kinds of advising relationships are viable in the humanities and social sciences because most faculty do not maintain labs or use expensive equipment. While GWS does not currently have a faculty member in Orillia, faculty in Interdisciplinary Studies and related programs can provide guidance on research projects relevant to the GWS Research Project.
