Pedagogical rationale for a) Complying with the changes Geography department is this proposal. Why are you proposing regarding Geog 1120 b) Updating course lists to submitting this request?: reflect the changes made in the major last year. This proposed minor in Sustainability will be hosted in the Department of Sustainability Sciences. The Department's educational focus is firmly rooted in the vision and mission statements of Lakehead University. The most recent academic plan of Lakehead University (2019-2024) seeks to promote academic strategies that focus on the delivery of high quality programs across the university, which include innovative and cross-disciplinary degree programs that embed experiential learning opportunities and reflect Lakehead's commitment to social and environmental justice, sustainability, interdisciplinary collaboration, and applied learning. Since its inception in 2014, the Department of Sustainability Sciences sought to promote interdisciplinary studies in environmental sustainability that adopted a student-centered learning process and inquiry-based pedagogical practices. To serve a diverse student community, the Department of Sustainabiliy Sciences built on these principles and founded various programs under the umbrella of HBASc in Environmental Sustainability major. However, these programs are available only at the Orillia and Barrie campuses. In an effort to widen the availability of educational opportunities in sustainability across Lakehead University and to promote more diverse pedagogical perspectives, the Department of Sustainability Sciences working closely with the Office of Sustainability is proposing a Minor in Sustainability that is intended to reach the entire Lakehead student body interested in sustainability regardless of their disciplinary focus. Through its delivery (inter-faculty teams) and content (large selection of elective courses), the new Minor in Sustainability uses a social-environmental systems approach that transcends disciplinary boundaries and incorporates diverse worldviews in a pluralistic, inclusive way.
