The course is structured as a seminar and envisioned as a collective exercise in critical thinking and practice. This seminar has been envisioned as a collective exercise in critical thinking. The interdisciplinary course is designed as a broad survey course that draws from the international relations and political science disciplines to review peacebuilding as a theory and practice, particularly in the context of new and recurring wars and conflicts.

Learning Outcomes: 1). Theories and images of international peacebuilding. Review and critically evaluate theories regarding causes of international conflicts and war and prospect for peace; 2). Mechanisms of international peacemaking. Gain insight regarding the factors of culture, gender, and power in the resolution of international conflicts and post-accord peacebuilding; 3). The role of different types of actors (e.g., diplomats, Indigenous peoples, citizen diplomats, media, international nongovernmental organizations, etc.) in international conflict resolution and peacebuilding; 4). Apply theoretical concepts of the course to conflict cases and enhance analytical and practical skills for addressing international conflict and for peacebuilding
