#### Program Requirements:

Bachelor of Arts, Bachelor of Education, (Indigenous Learning Major) Intermediate/Senior — Indigenous Teacher Education Program

This five-year degree plan is designed for students of Indigenous ancestry and leads to an Intermediate-Senior teaching credential in Indigenous Studies in Grades 7 through 12. Indigenous Language, French, or other subjects such as Geography may be integrated within this degree program to create an interesting and valuable teacher preparation experience. This degree program offers a great deal of flexibility and opportunity to "customize" the degree program for the needs of Indigenous students and their communities.

Indigenous Studies is the first teachable for this five—year degree program (5 FCE required). Students must have a minimum of 3 FCE in the second teachable. Students who wish to pursue a language as a second teachable, either an Indigenous Language or French, must have a minimum of 5 FCEs in the teachable.

- (a) Indigenous Learning 1100
- (b) English 1116
- (c) One-half FCE in English chosen from: English 1015, 1016, 1115
- (d) One FCE in a Indigenous Language chosen from a combination of: Cree 1010/Indigenous Learning 1011 and Cree 1012/Indigenous Learning 1013 OR Ojibwe 1013/Indigenous Learning 1014 and Ojibwe 1015/Indigenous Learning 1016 OR Ojibwe 1014/Indigenous Learning 1015 and Ojibwe 1016/Indigenous Learning 1017
- (e) One FCE in the second teachable See List of all Teachables (If the second teachable is Indigenous Language, choose an additional FCE in an Indigenous Language course. If the second teachable is French, choose one FCE in French language courses.)
- (f) One-half FCE elective in Type B courses or an additional half FCE in French language (if French is the second teachable)

this proposal. Why are you standard of practice. Education 1410 and Indigenous Learning submitting this request?: 1310 were switched to have the BA/BEd courses coincide with the HBEd (Indigenous Teacher Education) P/J program's courses. This allows for students to be taking their eduction course at the same time. The description of how to attain the Indigenous Language teachable has been edited for student clarification. Passed Faculty Council on October 11, 2017. In the fall of 2022, we replaced a required course: INDI 3501 (1.0FCE) with INDI 2012 (0.5FCE). Rational for this change: • Students currently entering INDI 3501 do not have

the disciplinary background and the first half of the course is spent teaching introductory materials that should have been introduced in a second year course. Thus, the shift of INDI 3501 to a second year course is done in order to provide the students with the necessary scaffolding to undertake a more senior level course (4th year) in this area. • Indigenous Learning also has a significant number of required FCEs (3.5/3yr BA & 4.5 4/yr HBA) and this is part of a broader curriculum revision that seeks to reduce the number of required FCEs for students and develop more scaffolding and preparatory work at the lower level so that students are better prepared to take on capstone projects in their fourth year classes. Unfortunately, we did not make the program specific changes in the calendar at the same time. Thus, this navigator change is to fix these problems. As a result of the changes we needed to fix the number of FCEs taken at the third year level and shift a required course from the third to the second year level.
