Title of Course: Land Relations

Course Description: An introduction into the ways in which colonial institutions, languages, and ideologies shape our

relationships with ourselves, each other, and the land. In particular, students will experience the land in and around Thunder Bay/Anemki Wajiw (eg, conservation areas, Anemki Wajiw). Everyone has a relationship to the Land — the question is what kind of relationship this is. Is it

reciprocal? Does it recognize agency beyond an

anthropocentric lens? What influences the ways that people

relate to the Land? How does that shape our social, ecological, economic, and cultural landscapes? What can change when we see the Land differently? In this course, we will look inwards at the layers of relationships that have influenced who we are, how we see ourselves, and how we see others. We will investigate how this impacts the way we understand the Land and our place in it. In this context specifically, we look at the ways that Indigenous

knowledges, languages, governance, and ways of being shaped human-Land relations since time immemorial and how colonial

institutions, policies, ideologies, and values have

attempted to disrupt (often, with violence) who has access to the land and how they are permitted to interact with it. Investigating these frictions, we see that the Land is already layered in ecological, political, social, economic, and cultural relationships, and that these relationships are

and cultural relationships, and that these relationships are important to know before we, as humans, educators,

recreators, guides, and scholars introduce ourselves to the

Land and build a new relationship. Through readings, podcasts, books, discussions, speakers, projects, and experiences on the Land, we will explore and reflect on these relationships together in an attempt to better "know" ourselves, each other, and the Land.
