Course Description: Explores ethical challenges across the research process—from design and community engagement to data collection, analysis, and reporting. Using case studies and core principles like consent, confidentiality, and ownership and control of data, students learn to navigate dilemmas and conduct responsible, reflexive research.

Why are you submitting this request?: This course equips students with the ethical literacy needed to design and conduct research in diverse academic, professional, and community settings. It is especially valuable for students preparing for independent research, community engagement, or work with vulnerable populations. This course will support research training and will be of interest to students in other programs. For example, is this change required for accreditation?

Learning Outcomes: 1. Analyze historical and contemporary ethical frameworks and guidelines to understand their implications for social research; 2. Critically evaluate ethical challenges that arise at each stage of the research process; 3. Apply core ethical principles such as respect for persons, informed consent, confidentiality, and ownership/control of data to real-world research scenarios, including work with vulnerable or marginalized populations; 4. Assess how social power dynamics, structural inequalities, and cultural contexts shape ethical considerations and responsibilities in research; 5. Develop ethically sound research plans, including strategies for community engagement, risk-benefit assessment, and data stewardship; 6. Demonstrate advanced understanding of Indigenous research ethics principles (e.g., OCAP®) and their integration into sociological research involving First Nations, Métis, and Inuit

communities; 7. Reflect critically on their own positionality and potential biases to conduct reflexive and responsible research practice; 8. Design and justify an ethics protocol that addresses potential dilemmas and meets institutional and community standards.
