4. QUESTION & ANSWERS

- **Q1.** In the furniture schedule, the armless chairs shown as "S3" refers to being used on LVT flooring in the "Type" and "description" columns but under accessories the spec asks for carpet casters. Can you please clarify whether hard floor or carpet casters are required on this chair?
- A1. Hard floor casters required on this chair.
- **Q2**. The description for furniture types WS1, WS1a and WS 1b asks for a ¾ modesty panel where the return runs against a wall, we offer a 9" wall access modesty panel for this application for full access to existing wall outlets. Is this acceptable?
- A2. Yes.
- Q3 The first line of the Furniture Schedule shows an item labelled as Type 3316B but has no description or tag. Is this to be included?
- **A3.** No. Disregard reference to Type 3316B.
- Q4 For the APP stool tagged as S4, can you please clarify the height required? This stool is available as either model 1403PS24 which has an overall height of 38" and seat height of 24" OR model 1403NS28 which has an overall height of 42" and seat height of 28". Please clarify what you consider to be "bistro height" as the T1 Standing Table is shown as 42" high but the T4 Bistro Table is shown as 29" high.
- **A4.** Model 1403NS28 (42")
- Q5 Under the "Type" column for the S4 chair, it is described as an arm chair with casters Bistro HT. However, in the specification it refers to a mid back stool. A stool will not be available on casters due to instability because of the higher height. Please clarify if casters are required.
- **A5.** Casters not required.

- Q6 Under the "Type" column for the S4 chair, it is described as an arm chair with casters Bistro HT. It also gives the Global specification for an APP stool however the APP stool does not come with arms. Please clarify if arms are required.
- A6. Arms are not required.
- Q7 For the S2 Nesting chair, the spec asks for a "mesh" back is a plastic poly back with cut outs for flexibility and breathability acceptable?

A7. No.

- **Q8** For T2 meeting table, please specify how thick the surface is supposed to be (Licence comes in 2 thickness options)
- A8. Surface to be 1.5" thick.
- Q9 The T5 lounge Coffee Table shows "56x22" in the description but the dimensions given refer to 48" x 22" x 15". Please confirm desired size.
- A9. T5 freestanding coffee table to be W54" X D20" X H15"
- Q10 Please provide a sketch and/or Zira product number for the storage under the return on the WS1 Desk layout. The description of the storage required does not match the price list and there does not appear to be a "Box File Open Storage" unit available at 42" wide.

A10 Zira Product # BRT29LOBF 42L

- **Q11** Please clarify sizes for WS1a and WS1b as dimensions given in dimension column are not 60"wide as described.
- A11 WS1a & WS1b are to be 60" due to space restrictions in specific offices.
- **Q12** Technical specifications and locations as per drawing A2.3 have been provided, however not overall sizes are detailed. Please provide size of WB1 whiteboards.
- A12 Overall whiteboard dimensions: W 2440mm, H 1220mm, D 12.7mm
- Q13 Question regarding the data cabling for the Lakehead University Paterson Library Teachers Common project. Would we be pulling the cable only or would it be a full install, pulling terminating, testing and labeling?
- **A13** Refer to the description for the New Communications Outlet under "Power/Systems Identification Legend" on drawing E1 which reads "...Final termination by Owner." For clarity, the contractor shall install data cabling and associated raceways. Final terminations, testing, labeling and cover plates will be by the Owner.

5. EQUALS & ALTERNATES

- **Equals and alternates are approved subject to the following conditions:
- 1) Any differences in equipment size, weight, dimensions, paint colour, orientation, wiring, pipe routing, ductwork connections, roof openings, wall openings, sound levels, voltage ratings, venting requirements etc. shall not result in additional cost to the contract, the owner nor the consultants.
