ARCTIC OIL: POLICY, LAW, AND INTERNATIONAL COOPERATION

Canada has four international legal disputes in the Arctic:

DISSOLVED ORGANIC MATTER IN NORTHERN DRINKING WATER

Dissolved organic matter (DOM) plays a dominant role in determining overall water quality. Comprised of thousands of molecules with varying structural and chemical properties, DOM can influence water taste, odour, colour, and treatability. For example, DOM can react with chlorine during the treatment of drinking water to form carcinogenic disinfection by-product.
