# Assignment 1

Keep a journal for 10 weeks consisting of three entries per week.

Topics must be related to urban residential geography (topics on course outline) and should include a mix of local (Simcoe County), provincial and national stories at least three at each scale. You may follow an ongoing story or have new topics each week.

Each entry should be about 100 words in length and consist of a précis of the news item and one sentence explaining how the item fits into the course. DO NOT submit the original article. The item may be taken from a newspaper, magazine or on-line daily or weekly source which must be referenced (APA). At least four different sources must be used.

Present as a typed single-spaced report. Assignment 2: As a university student you have had to make a residential choice: stay at home, live in residence, rent a house or apartment with other students, live in a rented basement (legal or illegal), live in your van or possibly some other option. Describe your choice and explain why you have chosen it. (If you have tried several options you may compare them). Evaluate if it has been a good decision or a bad one. If you wish to talk to your roommates or your classmates you may do so but you cannot conduct a questionnaire survey without approval of the ethics committee. In addition to your own research find three written articles (academic or non-academic) related to this topic.

Your report should be typed double spaced Times New Roman 12pt (or equivalent) 1500 words of text (+/- 10%) plus any tables, maps, figures as appropriate and a proper works cited page (bibliography)

Use the APA (author, date) method of referencing in the text.

**Assignment 3.** The textbook has ten chapters that we will not have time to discuss. Choose a topic from one of these chapters and write an essay about it as it applies to a community you are

familiar with. In addition to locally published material and/or media coverage, find three academic studies related to this issue.

Your report should be typed double spaced Times New Roman 12pt (or equivalent)

1500 words of text (+/- 10%) plus any tables, maps, figures as appropriate and a proper works cited page (bibliography)

Use the APA (author, date) method of referencing in the text.

- 3. Plagiarism of ideas and words as where words and an idea(s) of an author or speaker are incorporated into the body of a written assignment as though they were the writer's own words and ideas, i.e. no quotations or indentations (depending on format followed) are present and no referencing or footnoting or endnoting is given.
