The University is committed to fostering an inclusive climate of equitable access, understanding and mutual respect which recognizes the dignity and worth of all persons, provides equal rights and opportunities without discrimination, and protects the privacy, confidentiality, comfort, autonomy and dignity of students with disabilities.



Procedures (under review)

To preserve the academic integrity of the University, it is reaffirmed that all students must satisfy the essential requirements of their respective courses and programs while at the same time, recognizing that students with disabilities may require reasonable accommodations to enable them to do so.

Essential Requirements

Essential requirements of a course or program refer to the knowledge and skills that must be acquired or demonstrated in order for a student to successfully meet the learning objectives of that course or program.

For example, it may likely be an essential requirement that a student master core aspects of a course curriculum. It is much less likely that it will be an essential requirement to demonstrate the mastery in a particular format.



Academic Accommodations

Three key principles are inherent in the duty to accommodate:

- 1) Respect for the **dignity** of persons with disabilities, including integrity, empowerment, confidentiality, privacy, comfort, autonomy, individuality and self-esteem;
- 2) **Individualization**, meaning that persons with disabilities are individuals first, and must be considered, assessed, and accommodated individually; and the
- 3) Right of persons with disabilities to **integration and full participation**, which requires inclusive design of facilities, programs, policies and procedures, and barrier-removal where barriers are found to exist. (OHRC, 2001, p.7)

Complexity

The impact of the disability can vary greatly from student to student.

Students may have multiple disabilities.

Many disabilities are non-visible.

There may be medication or other issues related to the disability.

Conditions can be unstable, unpredictable and/or episodic.

English as a Second Language ESL

is not considered a disability



Disclosure

Disclosure of disability

- initiated by student
- voluntary outside of SAS
- students are not required to reveal their private medical information to, or seek accommodation directly from, their professors, instructors, teaching assistants, etc

What to do when a student discloses?



Accommodation Form

Should a student in your course engage with SAS for academic accommodations you will be sent a Confidential Accommodation Form. If a faculty member is concerned with the recommended accommodation or believes that the accommodation will jeopardize the essential requirements of the course, please contact Student Accessibility Services to discuss the concerns and potential alternatives.



Sample Accommodations

Lectures / Labs / Tutorials/ Practical Sessions

- Access to class notes, taping of lectures, use of FM, use of calculator, time extension for assignments, flexible attendance requirements

Tests and/or Exams

- extra time, use of computer (with or without assistive software), reader/scribe, distraction reduced, breaks, preapproved formula/fact sheet, restorative time between tests/exams, one exam per day, alternate form of testing (oral, essay/ MC), need to reschedule for disability reasons

Notetakers

- Notetaking is a volunteer service provided by a peer in the student's class.
- If a notetaker is requested for your class you will receive an email asking that you make an announcement and/or send an email to the class.
- Notetaking serves as an excellent addition to a student's resume and co-curricular.



Resolution of Disagreements

If agreement between the student, Student Accessibility Services, and the instructor(s) about a recommended accommodation plan cannot be reached, the instructor shall discuss the matter with the Chair/Director of the Department/School (normally within five Working Days of receipt of the accommodation request).
