# **OVERVIEW**

#### Data Source:

• Student Feedback on Teaching surveys collected in the 2021-22 academic year.

### About:

- Overall Results bar graphs depicting results for each of the 23 questions, with one tab with Faculty specific filters and one for Lakehead overall. Response options are aggregated to a 3-point scale for presentation.
- Question Means displays the mean score for each of the 23 questions based on assigning numerical values to the question response options, with one tab with Faculty specific filters and one for Lakehead overall. Null
  - and "not applicable" responses are excluded from calculations.
- Response Detail crosstabs providing the N values and percentage of all response options. Questions are split into two groups for presentation, with one tab with Faculty specific filters and one for Lakehead overall.

#### Criteria:

- Any course section which has at least 5 students enrolled is surveyed. This includes all student types (domestic, international, part-time, full-time) and course levels (graduate, undergraduate).
- · Cross-listed and cross-taught course sections may be combined for analysis.
- · Practicum, lab, placeholder, and thesis courses are excluded.

#### imitations:

· Course characteristics, including department and delivery method, are assigned based on course code.

#### Notes:

• The "Other" option in the Campus filter includes courses delivered at partner institutions, such as Seven Generation institutes or the Joint PhD in Educational Studies partners.
