OBJECTIVES AND CONTENT:

The purpose of this course is to familiarize the students with the quest for order and durable peace in world politics as per international law. It will analyze conflicts and conflict resolution mechanism from a variety of perspectives. The course will examine the theoretical and applied dimensions of contemporary security and conflict resolution mechanism. First, it will address the question of international law and global governance and then will investigate the question of security and conflict; the nature and causes of conflict; threats to peace and security. It will then look at a variety of proposals for eliminating war and conflict in order to provide peace and security to the nations of the world: types of negotiations and mediation practices, bilateral and multilateral negotiations, conference diplomacy, third party intervention, the UN system, functionalism, regionalism and new world order.

This is a seminar course and, therefore each class will be divided into two parts: The first half of the class will be based on lectures and the second half will concentrate on students' presentation, discussion and participation on assigned readings.
