The Department of Psychology at Lakehead University has an M.A. and a Ph.D. program in Clinical Psychology. The M.A. Clinical Psychology program was the first graduate program to be developed in the university, and similarly, the Ph.D. program was its first Doctoral program. The Ph.D. program has graduated 80 students to date, and in the last six years **96% of the graduates are registered for professional practice (or on track for registration)** with provincial regulatory Colleges. Our graduates have successfully registered in jurisdictions across Canada and internationally.
